CONDITIONS FOR REPRODUCTION PERMISSION

FEE TOTAL\$ _____ [TO BE COMPLETED BY THE BCMA]

Permission to reproduce is dependent on full acceptance of the following conditions and is automatically abrogated if any part is infringed.

1. Permission to reproduce works in the collection of the Bowdoin College Museum of Art must be obtained from the Assistant to the Registrar in writing prior to publication.
2. Reproductions must be made from photographic materials supplied by the Bowdoin College Museum of Art. Color reproductions must be made from 4x5 inch color transparencies, which are available on a rental basis. Black and white reproductions must be made from 8x10 inch glossy photographs sold by the Museum. OR, either color or black and white images may be reproduced from high resolution tiff or jpeg digital images, provided by the Bowdoin College Museum of Art. All color transparencies and digital images remain the property of the Bowdoin College Museum of Art and must be returned promptly after use.
3. Each image must be reproduced in its entirety without alteration, including cropping, bleeding off the page, overlapping, overprinting, or change in color unless otherwise approved in advance by the Bowdoin College Museum of Art. Any altered or detailed image must be labeled as "detail."
4. Rights to reproduce are non-exclusive and are granted for **one-time use only** as detailed on the application form. Any further revisions, editions or re-printings require a new application.
5. Photographic materials and permission to reproduce may not be reused, transferred, assigned, sold or otherwise disposed without written permission of the Bowdoin College Museum of Art.
6. If so requested, color proofs must be submitted to the Bowdoin College Museum of Art for approval prior to publication. The Bowdoin College Museum of Art reserves the right to deny reproduction if, after any correction, proofs are judged to be unsatisfactory.
