Books

Signing the Body: Marks on Skin in Early Modern France (New York: Routledge, 2020)

Signing the Body examines the representation of the body as a literally written or imprinted surface in early modern France. The book explores how the body served in the late 16th through early 18th centuries as a privileged surface for displaying authority and identity in a time of increased circulation of people and goods. Five chapters highlight intersections between marks inscribed or impressed on skin, writing and print culture, and commercial marking practices, examining: the invention of the "devil's mark" on witches; the use of textual and figurative stigmata by women religious; French accounts of Native American tattooing and the adoption of the practice by European inhabitants of

North America; the use of tattooing by European pilgrims who journeyed to Jerusalem and Bethlehem; and the rise of criminal branding by the state.

Stigma: Marking Skin in the Early Modern World, co-edited with historian Craig Koslofsky (University Park, PA: Pennsylvania State University Press, 2023).

The early modern period (c. 1450-1800) opened a new era in the history of dermal marking. Intensifying global travel and trade, especially, the slave trade, brought diverse skin-marking practices into contact as never before. *Stigma* examines the distinctive skin cultures and marking methods of Asia, Europe, Africa, and the Americas as they began to circulate and reshape one another in the early modern world. This interdisciplinary volume investigates how early modern people used permanent marks on skin to affirm traditional roles and believes, and how they hybridized and transformed skin marking to meet new economic and political demands.

Ongoing Book Project: Lunatics: Men, Women and the Moon in Early Modern France

This project examines popular and scientific ideas about lunar influence in early modern France, when the study of astronomy captivated the European mind while its companion art of astrology still played a major role in how people thought about themselves and their relationships to each other and to the universe. My study explores how the moon became a key vehicle for defining gender and performing social critique during the debates over male-female equality that raged from the sixteenth through eighteenth centuries, known as the *Querelle des femmes*. This interdisciplinary investigation puts into dialogue early scientific, popular, literary, and iconographic media to illuminate how both men and women used the trope of the moon and the study of astronomy to negotiate challenges to traditional gender roles and institutions and to raise questions about social norms and intellectual ability.
