Course Synopsis

Africa is portrayed as a continent in perpetual crisis, as we see continual images of civil war, refugees, poverty and disease. What has caused these calamities, and is there more to Africa than these images reveal? This course will examine societies and politics in sub-Saharan Africa, as we seek to understand the sources of current conditions and the prospects for political stability and economic growth. After a brief historical overview of pre-colonial society and colonial influence on state-construction in Africa, the course will look at three broad phases in Africa's contemporary political development: 1) independence and consolidation of authoritarian rule; 2) economic decline and challenges to authoritarianism; 3) democratization and civil conflict. As we look at these phases, we will find that there is a great deal of variation among states in the strength of their political structures, their economic performance, and their experience with violence.

Drawing from writings by African political leaders, novelists, anthropologists, journalists, and historians, as well as by political scientists, we will discuss reasons for these differences and learn how to engage profitably in comparative analysis. Students will gain a broad understanding of patterns and variation within Africa, along with a more detailed knowledge of everyday life and politics in a country of their choice. The course will give students tools to evaluate popular images of Africa from an informed perspective and to speak with insight about a continent that has inspired such perplexity.

Expectations

This course does not require any prior knowledge of African politics. It does ask for diligent attention to reading and written assignments, participation in class and readiness to learn.
