- A. EMPLOYEE'S SOCIAL SECURITY NUMBER: This is your social security number. The Social Security Number must match the number on your social security card. If there is a discrepancy, please contact Lynne Toussaint (<u>ltoussai@bowdoin.edu</u>)/ 207-725-3843) in the Controller's Office. The Controller's Office will issue a W-2C.
- B. EMPLOYER'S IDENTIFICATION NUMBER: This is Bowdoin College's Federal Tax ID Number.
- C. EMPLOYER'S NAME, ADDRESS, AND ZIP CODE: This is Bowdoin College's name, address, and ZIP code.
- D. CONTROL NUMBER: This is a Workday generated number based on your mailing address.
- E. EMPLOYEE'S NAME: This is your name.
- F. EMPLOYEE'S ADDRESS AND ZIP CODE: This is your address and zip code.
- 1. WAGES, TIPS, OTHER COMPENSATION: Shows your total taxable wages and other compensation that were paid during the year as detailed below.
 - a. Includes:
 - i. Total wages, additional compensation, bonuses and awards paid during the year
 - ii. Total noncash payments, including certain fringe benefits
 - Taxable cost of group-term life insurance in excess of \$50,000; displays on the top section of your W-2; the per pay period amount displays within the "Employer Paid Benefits" section of your payslip

- b. Excludes:

 - ii. Employee paid health care (MEDICAL, DENTAL, VISION); displays within the "Pre Tax Deductions" section of your payslip
 - iii. Healthcare flexible spending account deductions (FSA Healthcare, FSA Healthcare Vision Dental); displays within the "Pre Tax Deductions" section of your payslip
 - iv. Dependent care flexible spending account deductions (FSA Dependent Care); displays within the "Pre Tax Deductions" section of your payslip
- 2. **FEDERAL INCOME TAX WITHHELD:** Shows your total federal income tax withheld for the year.
- 3. **SOCIAL SECURITY WAGES:** Shows your total wages paid subject to social security tax (6.2% 2016); the taxable wage limits for 2016 is \$118,500.00.
 - a. Includes:
 - i. Total wages, additional compensation, bonuses and awards paid during the year
 - ii. Total noncash payments, including certain fringe benefits
 - iii. Taxable cost of group-term life insurance in excess of \$50,000; annualized value displays within the "Employer Paid Benefits" section of your payslip
 - iv. 403(b) deductions (Fidelity, Vanguard, American Century); displays within the "Pre Tax Deductions" section of your payslip
 - v. Designated Roth contributions made under a section 403(b) salary reduction agreement; displays within the "Post Tax Deductions" section of your payslip
 - b. Excludes:
 - i. Employee paid health care (MEDICAL, DENTAL, VISION); displays within the "Pre Tax Deductions" section of your paystub
 - ii. Healthcare flexible spending account deductions (FSA Healthcare, FSA Healthcare Vision Dental); displays within the "Pre Tax Deductions" section of your payslip
 - Dependent care flexible spending account deductions (FSA Dependent Care);
 displays within the "Pre Tax Deductions" section of your payslip
- 4. **SOCIAL SECURITY TAX WITHHELD:** Shows total social security tax withheld.
- 5. **MEDICARE WAGES AND TIPS:** The wages subject to Medicare tax (1.45%) are the same as those subject to social security tax (Box 3) except that there is no wage base limit for Medicare tax.
- 6. **MEDICARE TAX WITHHELD:** Shows total Medicare tax withheld.
- 7. SOCIAL SECURITY TIPS: N/A
- 8. ALLOCATED TIPS: N/A
- 9. Box unlabeled: N/A
- 10. **DEPENDENT CARE BENEFITS:** Shows your total pre-tax deductions (FSA Dependent Care) made under a section 125 dependent care flexible spending account; displays within the "Pre Tax Deductions" section of your payslip.
- 11. NONQUALIFED PLAN: N/A

- 12. **ELECTED DEFERRALS, OTHER:** May include a code with an associated amount. The most common codes reported on a W-2 issued by Bowdoin College are:
 - C Taxable costs of group-term life insurance over \$50,000 (included in boxes 1, 3 (up to social security wage base), and 5)
 - E Elective deferral under a section 403(b) salary reduction agreement
 - BB Designated ROTH contributions under a section 403(b) plan
 - DD- Cost of employer-sponsored health coverage. The amount reported within Code DD is NOT taxable
- 13. **RETIREMENT PLAN:** The retirement box is checked if you are eligible for any Bowdoin College paid retirement plan or you participated in a salary reduction arrangement under 403(b).
- 14. **OTHER:** Shows your United Way and/or Maine Share donations.
