# Am I qualified to supervise human subjects research?

## This questionnaire is intended to help you to determine the following:

- Am I qualified to supervise this project?
- Is the student qualified to take on this research?
- · Do I have professional capacity to supervise this student's project?

#### Responsibilities always include:

- · Guidance with research design
- · Support with the development of an informed consent process
- · Creation of a data storage plan
- · Review of multiple drafts of IRB protocol
- · Assuming responsibility for the ethical and responsible conduct of research
- · Ongoing check-ins regarding data collection, analysis, and presentation
- · Completion of CITI training

## Responsibilities may include:

- · Securing local contacts and approval letters
- · Assistance with translations

Before responding to the prompts below, please be sure to take the time to read these definitions culled from the Federal Policy on Human Research Protections, also known as the Common Rule.

"Research" is defined as "a systematic investigation, including research development, testing, and evaluation, designed to develop or contribute to generalizable knowledge." (§46.102(I)).

"Human subject" is defined ( $\S46.102(e)(1)$ ) as: a living individual about whom an investigator (whether professional or student) conducting research:

- (i) Obtains information or biospecimens through intervention or interaction with the individual, and uses, studies, or analyzes the information or biospecimens; or
- (ii) Obtains, uses, studies, analyzes, or generates identifiable private information or identifiable biospecimens.

Note that some scholarly and journalistic activities (e.g., oral history, journalism, biography, literary criticism, legal research, and historical scholarship) are not counted as research, namely when they "focus directly on the specific individuals about whom the information is collected." ((§46.102(I)(I)). When the scholarly or journalistic activity collects and uses information about specific individuals but does not generalize to other individuals, it does not count as human subjects research.
