This is a summary of financial information for the period beginning July 1, 2021 and ending June 30, 2022. The annual reports for each plan have been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

I. Bowdoin College Retirement Plan (Plan No. 004)

A. Basic Financial Statement

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$14,264,916. The expenses included \$68,773 in administrative expenses and \$14,196,143 in benefits paid to participants and beneficiaries. A total of 1,917 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$199,801,465 as of June 30, 2022, compared to \$238,784,660 as of July 1, 2021. During the plan year, the plan experienced a decrease in its net assets of \$38,983,195. This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$-24,718,279 including employer contributions of \$9,150,945, earnings from investments of \$-34,011,724 and other income of \$142,500.

B. Minimum Funding Standards

The amount of employer contributions to the plan was sufficient to keep the plan funded in accordance with the minimum funding standards of ERISA.

II. Bowdoin College Travel Accident Insurance Plan (Plan No. 506)

A. Insurance Information

The College has a contract with Hartford Fire Insurance Company to pay all claims incurred under the terms of the plan. The total premiums paid for the plan year ending June 30, 2022, were \$1,822.

III. <u>Bowdoin College Retirement Plan for Officers of Instruction & Officers of</u> Administration (Plan No. 002)

A. Basic Information

The value of plan assets, after subtracting liabilities of the plan, was \$4,215,926 as of June 30, 2022, compared to \$5,860,269 as of July 1, 2021. This plan is a frozen plan and as such, there were no contributions during the plan year ended June 30, 2022. The plan had total income of \$-757,067 representing earnings from investments. Plan expenses were \$887,276 representing benefits paid to participants and beneficiaries.
