Are there additional ways I can give to Bowdoin in honor of my 50th Reunion?

Yes! Of particular interest to those of us 70 ½ and over is the IRA Charitable Rollover. This type of gift allows individuals to avoid paying income taxes that were deferred when the funds were deposited. You might also want to consider a life income gift, a bequest, naming Bowdoin as a partial beneficiary of your retirement plan, using your Donor Advised Fund, and more – all of which will count as part of the Class of 1970's 50th Reunion Gift.
