

CAMPUS SECURITY AUTHORITY

A campus security authority is any individual (or individuals) who have responsibility for campus security, but who does not constitute a campus police department or campus security department. This includes officials of the College who have significant responsibility for student and campus activities, including, but not limited to, student housing, student discipline, and campus judicial proceedings. If such an official is a pastoral or professional counselor, the official is not considered a campus security authority when acting in that capacity. The Campus Security Authority members are trained annually.
